RESERVATIONS: A signed application, including NUMBER OF PERSONS OCCUPYING UNIT AND 50% RENTAL DEPOSIT, is required to reserve a Unit. If you have multiple choices with varying deposits, please enclose an estimated deposit amount with your Reservation Application. Once your reservation choices are finalized, any deposit shortfalls or overpayments can be corrected. A written Reservation Confirmation will be issued once your application and deposit is received, and we have ensured that we can accommodate your choice of accommodation and dates.

THREE or MORE CONSECUTIVE WEEKS in the same house: Reservation requests will be accepted by telephone at any time. Signed applications and deposits for telephone reservations must be received within one week to confirm a reservation.

ONE and TWO WEEKS: Reservation requests, with signed application and 50% deposit, are accepted BY MAIL ONLY until February 11, 2022. Reservation requests are welcome by telephone/email AFTER February 11, 2022. Signed applications and deposits for telephone reservations must be received within one week to confirm a reservation.

<u>PAYMENT POLICY:</u> Personal checks are accepted for all reservation deposits. If you have multiple choices with varying deposits, please enclose an estimated deposit amount with your Reservation Application. Once your reservation is finalized, any deposit excess or shortfall can be corrected. Final Payment, including rental balance and security deposit, must be received no later than 2 weeks prior to Arrival date, and may be paid by personal check. Final Payments received less than 2 weeks prior to Arrival date must be paid by cash, traveler's checks, certified check or money order. Sorry, we do not accept credit cards at this time.

SECURITY/CLEANING DEPOSIT: A security/cleaning deposit will be collected with the Final Payment for each unit. Houses will be inspected for DAMAGE and/or EXCESSIVE CLEANING after check-out. SECURITY DEPOSITS WILL BE RETURNED BY MAIL AFTER CHECK-OUT.

<u>CANCELLATION POLICY:</u> In the event of a cancellation, for any reason, all deposits will be refunded, minus a \$100.00 processing fee, ONLY if the property is re-rented under the same terms and conditions as the original rental. If we are unable to re-rent the property, all deposits will be forfeited to the Owner of the property. No refunds will be given in the event of hurricanes or other natural events. We recommend that you purchase travel insurance for such events.

OCCUPANCY LIMIT: Occupancy (including small children, infants and visitors) is not to exceed the occupancy limit for the unit. Pets are not allowed.
